

# **2021 Covid-19 Screening Questionnaire**

We ask that each student bring a fully completed and signed copy of this questionnaire with them to class each week or, for those taking multiple classes, at the beginning of each week.

Has your dancer recently tested positive for COVID-19, or, are you waiting to receive test results?

If "Yes" then following CDC and CRCHD guidelines the student must stay home.

If your dancer (regardless of vaccination status) has experienced any of the following symptoms in the past 14 days they may need to stay home.

Fever (100.4° F/37.8° C)

Cough, shortness of breath or difficulty breathing not allergy related

Sore throat

New loss of taste or smell

Chills

Abnormal headaches, muscle aches, general fatigue

Nausea, diarrhea, vomiting

*We generally follow The CDC recommendation that students experiencing the above symptoms stay home for 10 days and are completely symptom free for at least 48 hours.*

*Please do feel free to give us a call if you think it is safe for your student to come to class, seasonal allergies, a stressful day at school as well as many other things, can cause the above symptoms. No need to miss class because of homework overload or a high pollen count 😊.*

“Close Contact”: indoors within 6 feet of someone for more than 15 minutes over 24 hours or physical contact of any kind indoors or out.

1. In the past 14 days has your dancer (with or without a mask) been in close contact with anyone who was, or is, experiencing any of the symptoms on page one? Yes ☐ No ☐

2. In the past 14 days has your dancer (with or without a mask) been in close contact with someone who has since tested positive for COVID-19? Yes ☐ No ☐

*If the answer to question “1” or “2” is “yes” then, per the CDC, students who are symptom free should stay home for 14 days or have two negative Covid-19 PCR tests at least 72 hours apart. (For question “1” if the close contact person has two negative Covid-19 PCR tests at least 72 hours apart then the dancer can return to in-person class immediately). For students who develop symptoms please refer to page one.*

**Please complete the following for vaccinated and unvaccinated students.**

In the past 14 days, has your dancer always worn a mask while in close/extended contact with anyone outside of their immediate “bubble”. This includes eating indoors at restaurants, traveling, weddings, extracurricular school or church activities and other events where groups tend to gather. Yes ☐ No ☐

*If the answer is “No” to the above question we ask that the student wear a well fitted, unvented N95, KN95 or KF94 mask for 14 days after the close contact. This is a departure from the CDC guidelines; one that, combined with the other protocols in place at the Studio, should keep the risk level very low for all of the students. (We’ve worn a few N95 and KF94, they’ve been comfortable and even easier to breathe in than our everyday cloth masks 😊)*
